A RESOLUTION expressing support of the WV Community Development Hub in obtaining funding to support communities in the Monongahela Forest Region, including Petersburg, to continue building their recreational economies by intentionally supporting elements critical to sustained rural economic development.

Whereas, the WV Community Development Hub is seeking funding from the Appalachian Regional Commission (ARC) to provide technical assistance funding and ongoing technical services to individual communities located in the Mon Forest region to help them drive forward recreational development; and

Whereas, the City of Petersburg is a participating member in the Mon Forest Towns initiative, Along with nine other communities, and is seeking the assistance of the WV Community Development Hub to Provide essential services and technical assistance funding to continue building toward sustained rural economic development in the downtown; and

Whereas, a coordinated, multi-layered approach that provides focused technical assistance on entrepreneurial development and coordination, downtown building redevelopment services and technical assistance, and comprehensive community revitalization support including reuse, attracting and supporting business activity and promoting and bolstering economic assets in the downtown area of Petersburg.

Now, therefore be it resolved:

That the City of Petersburg wishes to express its support of the grant application by the WV Community Development Hub to obtain funds to provide technical assistance for downtown building revitalization, and municipality support to continue to build towards sustained rural economic development.
