CITY OF PETERSBURG REGULAR MEETING April 5, 2021

Mayor Michael called the Regular Meeting to order at 7:00 pm.

Councilman Feaster made a motion to approve the minutes of the Regular Meeting on March 1, 2021. Councilman Spanswick seconded the motion. The motion carried unanimously.

Councilman Feaster made a motion to approve the minutes of the Special Meeting of March 24, 2021. Councilman Spanswick seconded the motion. The motion carried unanimously.

PERSONS REQUESTING TO SPEAK TO COUNCIL

Becky Lanhart appeared before council to discuss the need for a city dog park. She asked the city to create an approximate 50" X 50" area fenced with a gate and benches for dog owners to sit while their dogs are exercising. She also asked that a "baggie" station be installed, and refuse can for waste disposal. She offered to pay for one half of the expenses if the city would move forward with the idea. She also stated the project would have to be monitored so it would not be abused. She offered to be the person in charge and contact person for any problems that would arise, she also said that Donnalie Hope will also help manage the project.

Kim Secrist, Gabe Mongold and Tammy Kimble appeared before council regarding Downtown Petersburg Beautification Project. Kim shared with council photos of ideas that are being implemented this upcoming year with the beautification project. Kim spoke of the water drip line and electricity being installed in the planters and the Grant County Magistrate Court. Gabe shared with the council a tree grant he is working on that will provide around fifty trees for the community. They discussed other details of the progress they have made and the plans of expanded plantings throughout Petersburg and the City Park. Kim asked the council to provide a water source to the flagpole in the city park, mayor and council agreed. Kim spoke of the business partners that have agreed to pay for the materials to have planters completed at their businesses and Kim will care from them throughout the growing season. Kim and Gabe spoke of the hayrack planters that will appear on the small- town bridge and then later grow to the larger river bridge eventually. Mayor Michael addressed the issue with First Energy and the poles. He reminded everyone of a meeting with a representative from First Energy to discuss the use of the poles that will take place at the depot.

Mayor Michael and the council presented the Downtown Beautification with their city paychecks for the month, each for \$92.35, to be used toward the city project.

Mayor Michael presented a Key to The City of Petersburg and thanks from himself and the council to Kim Secrist, Tammy Kimble and Gabe Mongold for their amazing commitment and endless hours of volunteered time to Downtown Petersburg Beautification.
