CITY OF PETERSBURG REGULAR MEETING August 9, 2021

Mayor Michael called the Regular Meeting to order at 7:00 pm.

Robert McCalley appeared before council to be renewed as the Petersburg representative for the Mon Forest Town Partnership Initiative.

Councilman Riggleman made a motion to renew the tenure of Robert McCalley as the Petersburg representative for the Mon Forest Town Partnership Initiative. Councilman Feaster seconded the motion. The motion carried unanimously.

Robert McCalley reported on the progress of the Mon Forest Town Partnership Initiative. He reported the Mon Forest Town Partnership is hoping to hire a grant seeker. He reported on the completion of the application of the WV Department of Highways Recreational Trail Program grant for the Petersburg River Park Hike and Bike Trail. The grant application is to develop three miles of asphalt paved trails on the top surface of the Petersburg levee system. The trail project will connect 60% of the community with a seven-foot-wide paved hike and bike trail. Mr. McCalley continued to report the US Army Corps of Engineers 408 certification permit has been submitted. He also reported the Petersburg Lions Club has written a letter to the Grant County Commission to adopt the trail and assume the responsibility of patrolling the trail and trash pickup as needed. Mr. McCalley also reported on the annual meeting of the Mon Forest Town Partnership and the confirmation of the strength and success of the recreational economies being built within our town's partnership.

Councilman Riggleman also stated there are 17 properties that have been noted with compliance violations. He reported they have sent 10 letters, issued 2 citations and 2 that have been corrected.

Taxation and Finance: Councilman Hyre reported information he has gathered regarding the best investment opportunity for the cemetery fund.

Water, Recreation and Pool: Councilman Spanswick reported the water and maintenance department have been repairing several leaks, the largest were at the Point and one on 220 South and Grove Street bypass intersection. The area of the Volunteer Fire Department and Walgreens should see a slight increase in their water pressure. He thanked Mark Geary for his help and locating all the pipes, shooting elevations so we now know where everything should be. The water department is waiting for a third bid on the clarifier removal, Councilman Spanswick thought he would have that in two weeks. He reported there will be a scheduled water shut down in September from the Post Office westward, they will install a fire hydrant, water supply and new meters installed. Councilman Riggleman reported the pool inspection by Cullen resulted in several write ups including benches that need attention, lifeguard stand bases are cracked and other minor repairs.

Sanitary Board: no report
